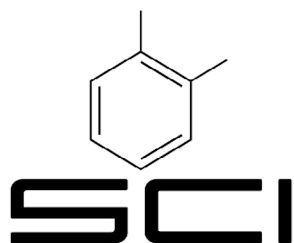

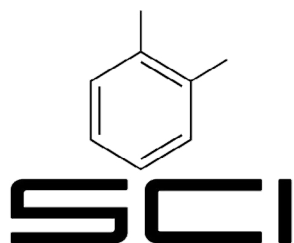

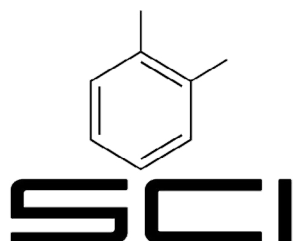

## SECTION 7. HANDLING AND STORAGE

### Precautions for Safe Handling

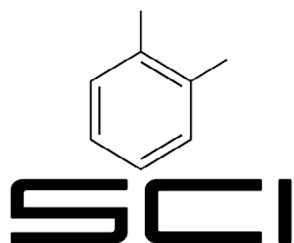

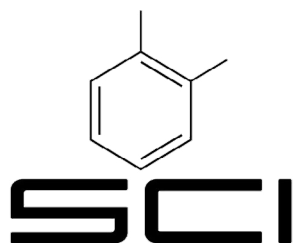
