

SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation:

IF INHALED: Remove person to fresh air and keep comfortable for breathing.

Skin Contact:

Flush with soap and water for a minimum of 15 minutes. Consult a physician if irritation persists or you feel unwell.

Eye Contact:

Rinse immediately with plenty of water for at least 15 minutes. Consult a physician.

Ingestion:

Rinse mouth and then drink plenty of water. Do not induce vomiting. Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions. Immediate medical attention required.

Most Important Symptoms and Effects, Acute and Delayed

Burning pain and severe corrosive skin damage. Can burn mouth, throat, and stomach. Can cause severe irritation and burns to the respiratory tract. May cause an allergic respiratory reaction. Causes serious eye damage. Symptoms may include stinging, tearing, redness, swelling, and blurred vision. Permanent eye damage including blindness could result.

Immediate Medical Attention and Special Treatment:

Provide general supportive measures and treat symptomatically. Chemical burns: Flush with water immediately. While flushing, remove clothes which do not adhere to affected area. Call an ambulance. Continue flushing during transport to hospital. Keep victim warm. Keep victim under observation. Symptoms may be delayed.

For containment, ensure adequate ventilation and absorb any spill with inert liquid binding material and dispose of waste safely.

HANDLING AND STORAGE

Precautions for Safe Handling

Provide suitable exhaust ventilation at the processing machines. Ensure thorough ventilation of stores and work areas. Avoid aerosol formation. When handling heated product, vapors of the product should be ventilated and respiratory protection used. Wear respiratory protection when spraying. Danger of bursting when sealed gastight. Protect against moisture. If bulging of drum occurs, transfer to well-ventilated area, puncture to relieve pressure, open vent and let stand for 48 hours before resealing.

Conditions for Safe Storage

Store in cool dry and well-ventilated place. Keep stored in accordance with local, regional, national, and international regulations. Store away from incapable materials.

Appropriate Engineering Controls

Local exhaust ventilation required. Make up air should be supplied to balance air that is removed by local or general exhaust ventilation.
